I declare that I have familiarised myself with the Regulations of the 7th Wrocław Night half Marathon, I fully accept its provisions and I will comply with them.

- 1. I declare that I am in good health and at the time of signing this declaration I am not aware of any medical contraindications to my participation in the 7th PKO Wrocław Night Half Marathon.*
- 2. I declare that I take part in the 7th Wrocław Night Half Marathon on my own responsibility and I am fully aware of dangers and risks which this sport event might involve, such as loss of health or death.*

At the same time:

- 1. I give consent/ do not give consent* to my personal data processing pursuant to Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (GDPR) by the Organiser of the 7th PKO Wrocław Night Half Marathon, that is Młodzieżowe Centrum Sportu Wrocław (Youth Sports Centre Wrocław) for the purpose of sending information about future sports and recreational events organised by Youth Sports Centre Wrocław.*
- 2. I give consent to a free of charge use of my image by means of registration and dissemination by the Organiser of the 7th PKO Wrocław Night Half Marathon, that is Youth Sports Centre Wrocław located at al. Ignacego Jana Paderewskiego 35 in Wrocław (post code 51-612), pursuant to the provisions of the Act of 4 February 1994 on copyright and related right acts and the Act of 23 April 1964 the Civil Code, and I authorise the Organiser to a free of charge use of my registered image in the following areas:

INFORMATION CLAUSE

Pursuant to art. 13(1)(2) of the Regulation of the European Parliament and of the Council no. 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter referred to as GDPR):

1. The Data Controller (DC) of your personal data included in the application form is Młodzieżowe Centrum Sportu Wrocław (Youth Sports Centre Wrocław) located at al. Ignacego Jana Paderewskiego 35, 51-612 Wrocław.
2. The DC appointed the data protection officer who can be contacted in writing with marking the addressee as the Personal Data Protection Officer under the address indicated in p. 1 above or to the e-mail address iod@mcs.wroc.pl or sekretariat@mcs.wroc.pl
3. Personal data provided by you will be processed for the purpose of performance of the contract connected with the participation in the 7th PKO Wrocław Night Half Marathon, legal basis: art. 6(1)(a)(b) of GDPR (data will be processed in order to conclude the contract and fulfil its provisions, carry out financial settlements, promotion activities within deadline necessary to met the above mentioned obligations).
4. The DC may communicate your data especially to the following recipients:
 - 1) the entities entrusted by the DC with data processing,
 - 2) other data recipients, such as insurers, providers of electronic payment services, banks, Internet service providers,
 - 3) sports organisations for the purpose of confirming meeting the criteria for the participation in the Crown of Polish Half Marathons
5. Your data will be processed for 5 years, that is the time required for the fulfilment by the DC of the obligations and rights resulting from the provisions of labour law related to the fulfilment of the organisational obligations of the event's Organiser.
6. You have the right to withdraw your consent, to access your data, rectify it, limit its processing, transfer and delete it, to transferring data within the scope resulting from the provisions of law (only for data regarding which a processing consent has been expressed, for the purpose of confirming meeting the criteria for the participation in the Crown of Polish Half Marathons and for sending information about future editions of Wrocław Half Marathon and other sports and recreational events organised by Youth Sports Centre Wrocław), as well as the right to access your own data, rectify it, limit its processing and to transfer it (regarding data processed on the basis of the concluded contract).
7. In order to exercise the rights described in p. 6 above, the requests should be submitted to the DC via the appointed Personal Data Protection Officer to the e-mail address iod@mcs.wroc.pl
8. You have the right to file a complaint to the Supervisory Body (as per GDPR) regarding the processing of your personal data; the Supervisory Body is the President of the Office for Personal Data Protection.
9. Provision of personal data by you is the condition for concluding the contract. Such provision is voluntary, however it will not be possible to take part in the 7th PKO Wrocław Night Half Marathon without providing personal data.
10. Your data will not be profiled.
